Bids to consider the purchase of uniforms and equipment for the Larimer County Sheriff's Department were received and opened on Wednesday, October 16, 2013 at 2:00 p.m. in the Purchasing Department. Bids were opened by Heather MacMillan, Purchasing Agent I and recorded by Les Brown, Department Specialist I. The following bids were received:

Gall's/Quartermaster LLC	\$29,355.00
Neve's Uniforms & Equipment	\$30,714.95
CPR Savers & First Aid Supply	\$44,410.78

No decision of award was made pending review and recommendation by the Larimer County Sheriff's Department.

The low bidder, Gall's/Quartermaster LLC bid a substitution for item 7b on the Bid Form (page 10), Raincoat, yellow, Neese 475SC *or approved equivalent*. It was determined by the Larimer County Sheriff's Department that the coat as bid was not an acceptable equivalent. Gall's/Quartermaster then provided pricing for the exact raincoat as detailed above, at an increased cost of \$35 per coat. As the Bid Form indicates the approximate quantity purchased annually for this raincoat is 4 units, this resulted in a minor change, and increased Gall's/Quartermaster's bid to \$29,495.00.

The Larimer County Sheriff's Department reviewed the bids and recommends accepting the bid from Gall's, Inc., per the attached departmental recommendation.

The Larimer County Purchasing Department concurs with the above recommendations.
